**Personal Notes on the  
Sanderlin and Mercer Families  
In  
Camden and Currituck Counties of North Carolina.**

**THE SANDERLIN FAMILY  
COX – MERCER – SANDERLIN**

Grandmother Sarah Frances Mercer-Sanderlin's family can be traced back to circa 1670 mostly through the Cox family. Mrs. Luna Jarvis-Spivey of 1419 Monterey Avenue, Norfolk, Virginia is the great-great granddaughter on her mother's side of Caleb Cox who was included in the 1790 United States Census, she has done considerable research on her family history and we are grateful to her for the following information on our Cox and mercer families.

THOMAS COX – Born circa 1670 and died in 1743, his wife was Ann. He made his Will on April 30<sup>th</sup>, 1743 and it was probated on July 5<sup>th</sup>, 1743. His sons were Edward, Solomon and Marmaduke. His daughters were Mary Cox, Dinah Cox, and Ann Cox. The executrix was Ann his wife. Will Book #1 Currituck County North Carolina.

MARMADUKE COX – Born \_\_\_\_\_ died in November 1806. He was the son of Thomas Cox. He made his Will on December 18<sup>th</sup>, 1802 and it was probated on November 18<sup>th</sup>, 1806. He mentioned granddaughter, Sarah Ballantine also Eathan and Frankie Cox. Son Thomas Cox was executor. John Ballantine was witness. Will Book #2 Currituck County N.C.

THOMAS COX – Son of Marmaduke Cox. Born \_\_ died in 1825. He made his Will on February 17<sup>th</sup>, 1818 and it was probated in May 1825. Will Book #3, Currituck County N.C. Sons; Thomas, Edward, John, David. Daughters; Fanny Cox-Bowren, Frances Cox-Mercer, Sarah Cox-Ballantine-Allison. Grandsons; David Cox and John Jordan Ballantine. Granddaughters; Milissa, Minnie, and Lover Ballantine the children of my daughter Sarah Cox-Ballantine-Allison. Son John was executor. Source of information on above wills; Clerk of the Court's record in Court House, Currituck N.C. 2; "Abstracts of Wills and Other Records. Currituck and Dare Counties 1663 to 1850" By Colonel Gordon C. Jones

The Frances Cox-Mercer mentioned as the daughter of Thomas Cox in his above will was my maternal great grandmother. We know she married Samuel E. Mercer from information in the Bible of my great aunt Anne E. Mercer-Overman-Taylor which reads.

"Anne E. Mercer was the daughter of Samuel E. Mercer and Frances Cox-Mercer was born October 11<sup>th</sup>, 1837 in Camden County North Carolina.'

According to information given to me by Aunt Betty, Elizabeth Estelle Sanderlin-Wood, her maternal grandparents Samuel E. Mercer and Frances Cox-Mercer had eight children, she believed they were all born and brought up in Camden County, North Carolina. She gave me their names in the order shown on the next sheet.

Samuel E. Mercer of Camden County, NC was born circa 1795. He married Frances Cox of Currituck County, NC born circa 1800, daughter of Thomas Cox. Their 8 children were;

Amanda Mercer- married first- Cox, second- Hathaway, third- William Henry Creekmore.

Cornelia Mercer married- Sears. Addie Sears Cater was their daughter.

Thomas Mercer.

William Mercer married first- Ann, second – Lou Williams.

Samuel Mercer married Susan Sanderlin of Camden County, born about 1832, died July 21, 1879. They had 2 children, William Thomas Mercer, born November 28, 1849 and John T. Mercer born November 1, 1851.

Sylvester Mercer.

Sarah Frances Mercer born June 20<sup>th</sup>, 1837, died Feb. 25, 1900 married Thomas Sanderlin of Camden County, born November 1, 1828 and died December 30, 1896. Thomas Sanderlin and his wife Sarah Frances Mercer-Sanderlin lived at Moyock in Currituck County, North Carolina. They had ten children and were my maternal grandparents.

Ann E. Mercer born October 11, 1837, married Nathan G. Overman of Pasquotank County, born Feb. 27, 1832 and died Feb. 15, 1883. Ann Mercer and Nathan Overman had two children. The first was George E. Overman who was born in Moyock N.C. on January 1<sup>st</sup>, 1858. On March 25<sup>th</sup>, 1890 George married Lizzie Griffin. The second child was Alice Overman – Born April 18, 1860, died 1865. After Nathan G. Overman died his widow Ann E. Mercer-Overman married William T. Taylor on October 11<sup>th</sup>, 1882. They had no children, William T. Taylor died in November of 1888.

- THOMAS SANDERLIN -

Thomas Sanderlin was born in Camden County, North Carolina on November 1<sup>st</sup>, 1828 and died at Moyock in Currituck County, North Carolina on December 30<sup>th</sup>, 1896. He was the son of Wilson Sanderlin of Camden County and Sarah his wife.

About 1850 he married Sarah Frances Mercer (1834-1900) of Camden County. She was the daughter of Samuel E. Mercer and Frances Cox-Mercer and the granddaughter of Thomas Cox.

Their 10 children were – William, Sarah Frances, Mary Gray, Thomas Mercer, Emma Susan, Edward Wilson, Clara Anne, Sam Sylvester, Elizabeth Estelle, and Lena Bridgett. Thomas Sanderlin was a plantation owner and a very successful farmer at Moyock, Currituck County North Carolina.

The Sanderlin's came to Currituck County from Camden County North Carolina, when they came and under what conditions we are not prepared to say. Although these counties are adjacent at the time of the 1790 Census there were 70 Sanderlin's in Camden and none in Currituck. Deed Book #13 page 199 in Currituck Court House records that Malachi Sanderlin of Camden County sold to Wilson Sanderlin, also of Camden, acreage in the Coinjock District of Currituck County, probably at Shawboro, on December 1<sup>st</sup>, 1812.

We know that grandmother Sarah Frances Mercer-Sanderlin came from Camden County by an entry in the Bible of great aunt Ann E. Mercer-Overman-Taylor which reads 'Ann E. Mercer of Camden County and Nathan G. Overman of Pasquotank County were married in October 1856 at Thomas Mercer's home by William Gordon. "Ann was the baby of this Mercer Family and was three years younger than her sister, Sarah Frances Mercer-Sanderlin. After their parents died both of these girls went to live with their brother Thomas Mercer who brought them up. My mother and grandmother appeared to think of Ann Mercer and Susan Sanderlin as special among their women relatives. They were Christian women of great character with engaging personalities. Ann and Susan wore their keys with distinction and efficiency.

The first land transaction of Thomas Sanderlin in Currituck County N.C. was in 1853. In Deed book 326, page 451 – "Thomas Sanderlin bought from John Barnard, May 6<sup>th</sup>, 1853 for \$3,000.00 land John Barnard purchased from Samuel Mercer bounded by land of William Mercer and the Drainage Canal, 250 acres more or less." It is extremely difficult to locate a piece of land by reading an ancient Deed, former owners are forgotten, lanes and roads change and the old oak tree dies and disappears. However I am inclined to believe this is the original Thomas Sanderlin Farm at Puddin Ridge which is two miles west of Moyock, North Carolina. This village was often referred to as Shingle Landing, the drainage canal mentioned in the above Deed ran by this farm and was called the Big Ditch, it drained the farms of this area into Shingle Landing Creek and on into Currituck Sound.

The dwelling on this farm was a story and a half cottage or story and a jump as the old folks said. Later as their family grew to ten children the girls slept in the main building with their parents, the four boys – William, Edward Wilson, Thomas Mercer and Samuel Sylvester slept in a building back of the cottage where there was a half dozen bunks. In the winter it was very cold in their bedroom but in those days in the winter it was cold everywhere inside as well as outside.

As time went on grandfather Thomas Sanderlin prospered for in 1855 we find him buying more land and building up to his plantation. Currituck County Deed Book #27, page 295. "Thomas Sanderlin bought from William C. Mercer May 29, 1855 for five hundred dollars, one hundred acres, bounded by Thomas Sanderlin's land, Maya Cox and Thomas Cox.

And again in 1857, Currituck Deed Book #27 pages 569 and 570. G.W. Parson sold to Thomas Sanderlin on the 20<sup>th</sup> of May 1857, 7 slaves, Martha and 3 children (Sarah, Amy

and Tom) Jacob, Ryland and Ned. 5 horses, 9 head of cattle, 40 or 50 heads of hogs, one third of a Lyghter named "Franklin Pierce" also a house and lot of two acres more or less at Shingle Landing together with all the buildings and improvements thereon which was purchased from W. W. Sylvester and Lindsay in February 1857. Also all of stock in Parson's Store at Shingle Landing, shoes, dry goods, hardware and his blacksmith shop.

Jesse Forbes Pugh in his book "THREE HUNDRED YEARS ALONG THE PASQUOTANK", states that in 1862 Major Willis Burgess Sanderlin (1829-1900) was in charge of the Home Guards of Camden County. At the same time Thomas Sanderlin was a member of the Home Guard at Moyock, N.C. Grandmother loved to tell of the time when it was Thomas' turn to be Camp Cook. He filled up a kettle with rice and filled the interstices with water. Naturally when the water began to boil the kettle of rice ran over so he had to keep adding kettles until the supply of kettles in the camp ran out. After that the boys made him a Captain or a Major or something so he would never again be on the cooking detail.

Around the middle of the 19<sup>th</sup> century there was an interesting Personality by the name of Dorsey Acy Sanderlin who moved about in the Currituck-Camden area of North Carolina. Although we have reports on him through several sources his relation to the Sanderlin Family remains elusive. In 1855 there is an official record where a Dorsey Sanderlin sold to John Barnard 300 acres for \$2,000.00 – Will Book 27 page 59 in the archives of Currituck County. Dorsey Acy was a Baptist Minister and during one period of his life established a Baptist Church at Rehobeth which is near Currituck Court House. I believe this place is now called Maple. Mr. Ben Sanderlin has encountered Dorsey Acy there is a delightful story. Isaac Newton Fentress, Ike, remembers him and that must have been around 1880 as Ike was born in 1869. Dorsey Acy often stayed at the home of great aunt Susan Sanderlin-Mercer-Fentress and Ike remembers that Dorsey Acy often addressed his mother Susan Fentress as Sister Susan, this was of course in the charming manner of all ministers of that period. In any event if he was a Sanderlin we know he was a Christian gentleman, kindly and gracious and we trust that someday he will be accord his proper place in history.

In 1878 Thomas Sanderlin bought from Mrs. Sabrina Wilson the Wilson Farm of 500 acres which was directly across the road from his outlined original farm at Puddin Ridge. I have not checked the deed on this transaction however Aunt Bettey said she was seven years old when her family moved into the Wilson House, she was born in 1871. Sabrina Wilson was by reputation the wealthiest woman in Currituck County, before she married William Stafford Wilson she was Miss Sabrina Boushell Cox. Sabrina was the maternal great grandmother of Luna Jarvis-Spivey, My grandmother's people all called her Cousin Sabrina Wilson, the relationship however remote was with the Cox Family also way back in Camden County days there may have been a marriage between the Sanderlin's and the Wilsons, at least half a dozen Sanderlin boys were given the Christen name of Wilson.
